

**SUPPLEMENTAL AGREEMENT NO. 1  
TO PROFESSIONAL SERVICE AGREEMENT  
BETWEEN SNOHOMISH HEALTH DISTRICT AND  
BUENAVISTA SERVICES INC.  
FOR JANITORIAL SERVICES**

This Supplemental Agreement No. 1 is made and entered into on the 29th day of June, 2020, between the SNOHOMISH HEALTH DISTRICT, hereinafter called "SHD" and BUENAVISTA SERVICES INC. hereinafter called the "Contractor."

WHEREAS, the parties hereto have previously entered into an Agreement for Janitorial Services,

WHEREAS, SHD desires to supplement said Agreement, by modifying the Scope of Services,

NOW THEREFORE, in consideration of the terms, conditions covenants and performance contained herein or attached and incorporated, and made a part hereof, the parties hereto agree as follows:

Each and every provision of the Original Agreement for Professional Services dated 12/23/2019 shall remain in full force and effect, except as modified in the following section:

- Exhibit 1 Statement of Work Part A. –
  - To remove Lynnwood WIC Clinic from the Agreement as a place to be served as of July 8<sup>th</sup>, 2020
  - To add Suite 208 at the Rucker building as part of the occupied space to be served as of June 26<sup>th</sup>, 2020

The Total Amount payable to the Contractor is summarized as follows:

- Original Agreement: \$4,911.95 per month
- Removal of Lynnwood location: \$-1,385 per month
- Addition of Suite 208 at Rucker location: \$695.00 per month
- Adjusted total amount: \$4,221.95 per month for services
