Briefings

Discussion of Snohomish County's plan to absorb the Health District into County Government

Members from the Snohomish County Executive's Office briefed Council members on the activities and actions taken thus far into integrating public health into County government. Council members discussed the timeline of events leading up to informing the PHAC of the process with the majority of PHAC members



expressing a desire for a separate meeting or conversation to discuss the order of events leading up to the announcement to integrate. County staff shared a presentation on the overall integration structure and planned workgroups for the coming months. County staff invited PHAC members to reach out to them directly with any questions regarding the merge.

Mr. Sean Edwards voiced frustration regarding solid waste created due to backyard flocks. Mr. Edwards spoke in favor of integrating the public health into County government but also shared concern that the PHAC was not a part of the conversation earlier on.
