

Community Health Assessment

A community health assessment (CHA) is a county-wide health assessment that identifies key health needs and issues through a systematic, comprehensive data collection and analysis.

CHA/CHIP (Community Health Improvement Plan) cycle



2022 CHA process

Recruit community participants

- Data committee
- Key informant interviewees and focus group participants

• Data Collection: qualitative/quantitative

- Trends over time
- Comparison of local data, state data, national data, and national goals/recommendations
- Local data by age, gender, race/ethnicity
- Key Informant Interviews and focus groups (quantitative)

Data review & prioritization

Data Committee meetings and prioritization retreat

6 top health priorities identified by the Data Committee

- Persons experiencing homelessness
- Opioid overdoses
- Inadequate prenatal care
- Mental health access and provider ratios
- Adverse Childhood Experiences (ACEs)
- Food security

Top health issues and barriers to good health identified by the community through key informant interviews and focus groups


Health care

- Basic needs food, shelter, hygiene, etc.




Top health priority *Opioid overdoses*




Top health priority *Mental health access and provider ratios*

Percent of students⁺ in Snohomish County with an ACEs score of 3 or more by demographic characteristics, 2021






