## **Call to Order**

The regular meeting of the Board of Health was called to order using a hybrid setting at 3:03 p.m. by Ms. Megan Dunn.

### Roll Call

Roll call was taken by Ms. Sarah de Jong who reported there was a quorum present.

### **Approval of Agenda Contents and Order**

It was moved by Mr. Desmond Skubi and seconded by Ms. Lisa George to approve the agenda contents and order. The motion passed unanimously.

#### **Approval of Minutes**

2023 Board of Health Workplan (SR 23-004C; N. Thomsen)

## **Briefings**

Snohomish County Code Update (SR 23-011; N. Thomsen)



Administration

Ms. Thomsen shared that updates to the County Code have been approved by the County Council and walked through the specific revisions that were approved.

Snohomish County Board of Health Code – Part 1 (SR 23-009; R. Gray)

Ms. Ragina Gray laid out the process for revising and implementing the Snohomish County Board of Health Code and shared the updates that have been made so far.

Community Health Assessment (SR 23-010; M. Blatt)

Ms. Miyuki Blatt, Epidemiologist, shared a presentation on the recently completed community health assessment. The top six priorities identified in that assessment are:

- Person experiencing homelessness
- Opioid overdoses
- Inadequate prenatal care
- Mental health access and provider ratios
- Adverse Childhood Experiences (ACEs)
- Food security

## **Department Report**

Mr. Dennis Worsham shared departmental updates that included:

- Board of Health code was adopted by the County Council
- The Community Health Assessment is complete
- The Community Equity Advisory Board and Public Health Advisory Council have ben detached from the Board of Health and are now advisory groups to the Health Department
- The process to hire a manager for the Sound Foundation is moving along
- The Department is looking forward to strategic planning and forming new partnerships with community organizations
- The Department will be re-instating its STD clinical services
- The Department will also be moving forward with a Gold Standard Review
